Virtual presentations included a Genealogy series and an Estate Planning series, as well as sessions on Human-Robot Interaction Teams, US Economy Update, Assistive Technology, The War in Ukraine, What's Happened to the Republican Party, Nuclear Power & Climate Change, Electronic Vehicles, Gerrymandering, An American Living In Gascony, Solar/Sustainable Energy, Inflation Reduction Act, 2023-25 State & University Budgets, Local Resources for Retirement, Income Tax Preparation, and UW-Madison on Social Media.
