
Focal Points and other Community Partners

What is AAA of Dane County?

- Area Agency on Aging (one of three in Wisconsin)
 - GWAAR and Milwaukee are the two others in Wisconsin
- Supports successful delivery of aging programs
- Provides the following to ensure quality programs and services for older adults:
 - Policy interpretation / assistance in implementation
 - Training
 - Technical assistance
 - Advocacy
 - Quality assurance and improvement
 - Area Planning for Aging
 - Funding



Focal Points of Service



OAA Title III

- Cannot Supplant Other Federal Funding (Medicaid)
- Target populations:
 - Low-income older adults
 - Older adults from minority populations
 - Older adults living in rural areas
 - Socially and economically needy
- No income or asset test
- People must have the opportunity to contribute but they cannot be charged a fee
- Counties must match 10-20% of all money.



Title III Part B: Supportive Services

Supportive Services for the general well-being (mental & physical) and welfare of older adults

Title III B: Supportive Services

- Legal Services-Elder Benefit Specialists
- Coordinated Transportation Services-RSVP Driver Escort, Vet's Helping Vets
- Volunteer Programs-RSVP, Guardianship/Rep Payee
- Community-based support services-Diversity & Inclusion Programs (Black/Latinx/SE Asian, Volunteer or PaidChore, Homemaker and Personal Care

Some Supportive Services Require Focal Point Case Management involvement.

Elder Benefit Specialists

- The EBS Program provides free advocacy and legal advice/representation for senior adults (age 60+) residing in Dane County that are faced with benefit, housing and other disputes or denials, complications, changes in benefits, claims not paid, and other similar issue groups that have an economic or socially isolating effect on the older adult.
- Elder Benefit Specialists (EBS) receive in-depth, on-going legal training. EBS staff, along with their program attorneys at the Greater Wisconsin Agency on Aging Resources (GWAAR) and AAA management, prioritize legal case work based on client need.

EBS High Priorities

- An appeal/denial/reduction of existing benefits with approaching appeal deadlines
- A late appeal where deadline has passed
- > Medicare billing or coordination issues with approaching deadlines
- Pharmacy or drug coverage issue where client needs medication immediately
- > SSA overpayment issues prior to 30 day deadline from notice
- > Specific housing eviction issues, deadline-related housing crisis

EBS Normal Priorities

- Debt collections and consumer issues
- General benefit appeals or denials or loss of existing benefits
- Guardianship and POA issues/questions
- > LTDI/STDI or COBRA questions and coordination issues
- Medicare appeals or Explanation of Benefit (EOB) appeals and billing problems
- Pharmacy drug coverage issues
- Private health insurance appeals & denials
- Spousal impoverishment issues
- > SSA overpayment issues beyond 30 days of notice
- SSI/SSDI initial application assistance

Elder Benefit Specialist Referrals

Potential EBS clients who present with issues on the priority lists should first contact the ADRC Information & Assistance helpline by calling (608) 240-7400. An I & A Specialist will discern their particular issue, in many cases assist the client to resolve the issue, or escalate their issue to an EBS through an internal referral to the program if necessary.

Case Management

Primary goal is to provide older adults with the support they need to achieve and maintain optimum independence in their community through the assessment of need and the coordination and monitoring of community-based services.

Dane County is the only County in WI with a case management program. Case Management is not a mandated service, but IIIB funding can be used for this purpose. For this reason and the small amount of IIIB funding most counties receive, they cannot afford to use it for case management. Nor can Dane County, and thus this program is funded by tax levy entirely.

- Breakfast or Lunch Restaurants have 8-10 choices
- Hmong Culturally Specific Meal 5 days per week
